Preface and Acknowledgements

Three separate organisations collaborated in the production of this book: The French Institute of South Africa (IFAS), the Foundation for Global Dialogue (FGD) and the Human Sciences Research Council (HSRC). In addition, three academic bodies made important contributions both to the planning of the conference on which this book is based as well as to the editorial panel which selected conference papers for publication. These are the African Studies Association of South Africa, the African Association of Political Sciences, and the Council for the Development of Social Science Research in Africa.

The conference was held in Cape Town during the second half of 1998. Thirteen papers were delivered over a two-day period. Nine of these papers were subsequently selected and authors were requested to finalise these for publication.

The publication is situated within the field of identity politics and constitutes a second volume in a series on this subject. The first volume, entitled *Identity? Theory, Politics, History*. Volume 1 was published in 1999 by the Human Sciences Research Council and was based upon an earlier conference organised by the same three collaborating organisations. Though Volume 1 included a chapter comparing processes of identity construction in Reunion and in South Africa, its geographical focus was on South Africa. Volume 2 extends this focus to the African continent as a whole and, in one chapter, to Europeans of African descent.
